The purposes for which the Foundation is incorporated are educational and cultural activities between the Polish Republic and the United States of America, especially organizing the exchange, promotion and educational assistance to children, adolescents and adults as well as educational and cultural activities especially aimed at supporting the development of civil society in Poland, promoting citizenship and rapprochement between the peoples and countries of the world.

# The Foundation will achieve the above purposes by various means, including but not limited to the following:

- b) organizing courses, exhibitions, demonstrations, lectures, discussions, symposia, seminars, conferences, workshops, campaigns, educational and cultural programs, etc., consistent with the objectives of the Foundation,
- c) cooperation with public, non-public and non-governmental organizations active in the field consistent with the objectives of the Foundation,
- d) organizing an international cooperation with institutions and organizations with similar objectives as the objectives of the Foundation,
- e) promotion of the development of intercultural education, education for human rights and global education in primary and secondary schools,
- f) publishing activities, consistent with the purposes of the Foundation,
- g) scientific research and popular works devoted to the development of intercultural education, education for human rights and global education,
- h) granting scientific, cultural, artistic and other scholarships, supporting

# Foundation activities realized between 1 January 2017 and 31 December 2017:

1. Re-entry Seminar for FLEX alumni 2016/2017

Between 20 and 23 July in Warsaw we organized Re-Entry Seminar for participants of the FLEX Program who have just returned from the United States. Within three days, we had the opportunity not only to reflect on what this experience taught us, how we have changed, how the reality have changed around us but we also took part in the project management training and we prepared our first actions.

On Sunday, July 23 we conducted classes of English and Polish for a group of 30 young people from Ukraine, Russia, Kazakhstan, Belarus and the United States. These people stayed in Poland on a language course organized by Fundacja i Szkoła Nauki Języków Obcych "Linguae Mundi".

- 2. FLEX Program Implementation 2017/2018
  - a) Notification meeting for the parents of FLEX Program Finalists and Alternates

Second informational meeting for the parents of FLEX Program Finalists and Substitutes took place on May 14th. It was attended by more than 100 people: finalists, substitutes, their parents and siblings as well as FLEX Alumni. There was no end to questions, especially asked to the FLEX Alumni who stayed for an hour after the meeting to talk with Polish Participants. The meeting was made possible thanks to the courtesy of Warszawskie Centrum Innowacji Edukacyjno-Społecznych i Szkoleń and Centrum Zasobów Dydaktycznych Języka Angielskiego, who offered the room free of charge. b) Pre-Departure Orientation Training

Pre-Departure Orientation Training for the participants of FLEX Program took place between June 25th and 28th in Wilga. It was attended by all the finalists as well as two trainers from USA and two Program Alumni from Ukraine. For the four days of training the finalists discussed such topics as: the rules of the Program, American high schools, host families, friends, free time in USA and cultural diversity in USA. It is worth noting that the training was concluded by a reception at the residence of the US Ambassador to Poland, Mr Paul W. Jones. The aim of the training was to prepare the participants for the best possible experience of the 10 following months in the USA. The days of training were very intense, filled with practical tips as well as with laughter and positive energy.

  - 3. The implementation of FLEX Program for 2018/2019
    - a) Recruitment for the Program

Between September and December 2017 recruiting for FLEX Program 2018/2019 was conducted. The on-line application was filled in by 2681 students. Information about the Program was posted on over 80 websites; we contacted more than 400 middle schools and high schools. High application rate of the students with disabilities is a recognizable achievement for this year's recruiting.

In November and December 2017 first semi-finals were organized: in Wroclaw, Poznan and Warsaw. They were attended by more than 200 students. The tables below represent statistic of current year recruiting.




Table 1. Applicants' breakdown by "Testing Center"




Table 2. Applicants' breakdown by voivodeship




Table 3. Applicants' breakdown by gender.
